# Top 5 Questions You Should Ask Your Defense Counsel

In last month's column, I gave you 5 questions you should ask <u>before</u> hiring a lawyer to handle your claims. Here are some questions that you should ask <u>after</u> you have hired that attorney:

#### 1/How Did The Latest Event Affect The Case?

Anyone can report on how a site inspection, deposition, pretrial or other significant event went. However, your defense counsel owes you more than a simple report. Your counsel should also explain the impact of an event on the case.

## 2/How Much Will This Cost?

Most attorneys will give you a budget at the start of the case. However, it will not help you a year later when you have to go to your boss and explain why your litigation costs exceed your reserves. Defense counsel must continuously keep you updated regarding how much you are spending and why.

#### 3/What Is Your Closure Plan Of Action?

Every step that you and defense counsel take in a case must be towards closure. The claim is not going to get cheaper as it continues. Your defense counsel has to be laser-focused on the goal of closing the case as quickly and as cheaply as possible.

## 4/What Else Can We Be Doing To Close The Case?

Your counsel needs to think outside the box. You do not want worthless status updates telling you that nothing is going on with the case and it was simply continued. Your attorney needs to be filing motions to dismiss, obtaining trial dates and using tools like mediation and settlement days to close the case ASAP.

#### 5/What Are My Chances Of Success?

A lot of attorneys don't want to go out on a limb and tell a client how likely it is that a given plan of action will succeed. It is our job as defense counsel to take that stand. Do not accept wishy-washy opinions or ones that shift responsibility to you. You are paying your defense counsel to provide their expertise, so demand that they do so.

SOUND BITE: MIKE ZALEWSKI

On Legal Face-Off's recent episode, Illinois State Representative Mike Zalewski joined Rich to discuss his first-in-the-nation legislation regulating daily fantasy sports.

**Rich Lenkov:** Rep Zaleski, good morning and thanks for joining us. There's been a lot of talk lately about daily fantasy sites like FanDuel and DraftKings. They've been all over the news. To be clear, your bill is not seeking to make these kinds of sites gambling, what you're doing is trying to impose some standards on people who use them and how they're being used.

**State Representative Mike Zalewski:** Yeah what we tried to do in this bill is create a best practice act. So right now there's a nebulous view of what daily fantasy sites are. Are the gambling? Are they a game of skill? So we created an act dealing with daily fantasy contests and then we defined how we want them to behave. Things like: preventing underage players from playing, protecting the money when it's deposited into the account and trying to develop a protocol when you see someone playing maybe way too many times. Those are the types of things the bill does to protect players and allow people to enjoy the games.

**Rich:** To clarify, there's a federal law that says you cannot gamble on the internet if it involves playing a game a chance. In Illinois however, it's different. The law says that internet gambling is a game of chance or skill for money. Isn't that an important distinction?

**State Representative Mike Zalewski:** My understanding is our gambling statute is silent on daily fantasy and defines gambling as consideration + x = chance. There's a sanction on the laws right now that if you gamble over a telecommunication line you're guilty of a Class-A Misdemeanor. Our bill changes that and excludes daily fantasy from that definition.

# Rauner Unveils Proposal To Sell The Thompson Center

Gov. Bruce Rauner recently proposed a plan to sell, and likely demolish/rebuild, the James R. Thompson Center, located in the Chicago Loop. The Thompson Center currently houses the Illinois Workers' Compensation Commission. Rauner explained, "For the people that work here...it's hard to move through the building,

very ineffective, noise from downstairs, smells from the food court all get into the offices."

The open air atrium and glass panel design of the building has proved inefficient to maintain, heat and cool, at the costly price of \$100 million. The Thompson Center was built in 1985, designed by architect Helmut Jahn. Jahn remarked that he and former Gov. James Thompson shared a vision that the building would be a "symbol for the openness and transparency of the state government…a lively urban and public place." That goal, according to Jahn, "has not been upheld by the administrations that followed."

Under Rauner's plan, the building will be sold at a public auction. An estimated 2,200 state workers would be sent to other state-owned property in Chicago and Springfield. These moves could save taxpayers \$6-12 million a year. Rauner aims to have the transaction completed in one year and says that site appraisals are in process.



# Petitioner's Lack Of Sufficient Job Search Dooms Permanent Total Disability Claim

In *Brice v. City of Chicago 23 ILWCB 139 (III. W.C. Comm. 2015)*, the Commission recently held that Petitioner failed to demonstrate a credible job search and denied his claim for permanent total disability benefits. Instead, the Commission awarded Petitioner permanent partial disability

benefits for 15% loss of use of man as a whole and 3% loss of use of the leg, resulting in a significantly lower award.

Petitioner worked for the City of Chicago as a truck driver for over 16 years until he slipped and fell on ice, injuring his left knee and back. Petitioner was unable to return to work and given permanent work restrictions by his treating physicians, which the City was unable to accommodate. Petitioner underwent a self-directed job search and testified that he found job leads through classified ads. Petitioner also kept a job search log, but the log did not show a single application submitted to an employer. The Commission also noted that Petitioner did not begin the job search until one year after he was given permanent restrictions.

The Commission denied Petitioner's PTD claim, finding that Petitioner's job search was insufficient to establish that he did not have a stable labor market. The Commission also noted that Petitioner limited his job search by imposing his work restrictions on potential jobs.

## **Practice Tip:**

All aspects of Petitioner's job search should be questioned and investigated. A qualified vocational rehabilitation expert can prove that most petitioners who claim that they are permanently and totally disabled can find work and are employable

# **Benefits Rolling Away**

In *Daymon v. Vienna Correctional Center*, 23 ILWCB 135 (III. W.C. Comm. 2015), The Commission found a rolling chair injury not compensable. Petitioner alleged that he was filling in for another employee and sitting in a rolling chair when he reached for the phone and his chair "popped" out from under him,

injuring his back.

The Arbitrator denied benefits, finding that the chair simply rolled out from under Petitioner. The Commission affirmed, citing the neutral risk doctrine. A neutral risk is compensable when Petitioner is exposed to a quantitative or qualitative risk greater than the general public. The Commission noted that Petitioner was not working his regular job, so there was no higher quantitative risk. Additionally, as Petitioner failed to prove a defect caused by the employer, there was no qualitative risk either.

#### **Practice Tip:**

It is Petitioner's burden to prove the compensability of his or her case. Sustaining an injury while working doesn't automatically provide a right to benefits.
