Top 5 Questions To Ask A Potential IME Doctor

Section 12 gives parties the right to select an independent medical examiner. Before getting stuck with a bad one, ask these questions:

1/ Are you board certified?

Board certification is not mandatory to practice medicine. However, it is almost a necessity when choosing an expert, as it connotes a certain level of expertise that you want in a retained physician.

2/ What percentage of your practice is devoted to litigation?

The best experts are ones that spend most of their time treating patients, rather than litigating. Professional litigants are not as credible as doctors who spend most of their time seeing patients. There is no magic number, but stay away from doctors who spend more than 15% of their time on litigation.

3/ Any disciplinary actions?

This is easily searchable on various web sites. It is important to know if your expert has had any disciplinary actions or medical malpractice cases that may adversely affect their credibility.

4/ Are you an expert in the specific subspecialty?

Hire an expert with a long and credible track record with the specific body part he or she is examining. A doctor who has treated thousands of patients with a similar condition is more credible than a generalist.

5/ How much work do you do for employees?

You want a doctor who works for both Petitioners and Respondents. One who exclusively represents employers could be perceived as a hired gun by the Commission.

SOUND BITE: IAN MILLHISER

On Legal Face-Off's recent episode, Senior Fellow at American Progress, Ian Millhoser, joined Rich and Jason to discuss the legal debate over accepting Syrian refugees .

Jason Whiteside: Ian, before Friday's attacks in Paris, the U.S. had no issue accepting refugees from anywhere in the world. Is this just a knee jerk reaction to the attacks and are the governors going to realize there's not much hope to fight this and accept the refugees?

Ian Millhiser: Certainly I think this is an ill-considered reaction to what has happened. You brought up the issue of religious discrimination, which is unconstitutional. One thing we cannot do under our constitution is say there can only be Christians and not Muslims admitted through a government program. But, as a matter of counter terrorism, that is a foolish thing. It is a reckless thing for American officials to say...

Rich Lenkov: So it seems clear that the governors are flat out wrong legally when they say they can do this, but what if the president comes out and says that he wants to ban refugees? What if we elect a president who now says, "well, I am changing our policy"? Does he have any legal standing to suddenly reverse course and say that we will not, as a country, accept refugees from Syria?

Ian Millhiser: The immigration law generally gives a tremendous amount of discretion to the executive branch of government. So yes, it

does matter a great deal who is president...But under the law, whoever the president of the U.S. is, that person has a great control over what the refugee policy is.

Petitioner's Accident 'Tripped Up' By Commission

In Loeb v. Northshore University Health System, 23 ILWCLB 155 (III. W.C. Comm. 2015), the Illinois Workers' Compensation Commission determined that Petitioner's tripping over a curb in her employer's parking lot did not arise out of her employment.

Petitioner, a nurse researcher, was required to travel to various hospitals in response to medical emergencies. Petitioner's parking spot was located in the main lot that was open to patients, visitors and hospital employees. On the accident date, Petitioner testified that she moved to avoid a vehicle and tripped over a curb, injuring her left arm.

The Commission, affirming the Arbitrator's decision, found that tripping over a curb was a risk faced by all members of the public. Therefore, there was no risk connected with or incidental to Petitioner's employment. The Commission noted that there was no defect in the curb or ice, snow or rain accumulation where Petitioner fell.

Practice Tip:

Tripping on a curb in an employer's parking lot is often considered a non-compensable, neutral risk. When assessing a parking lot case, be sure to consider whether the parking lot is open to the general public, whether there were any defects in the parking lot or curb at the time of the accident and whether the entrance is used by the general public.

The Weight Of An AMA Impairment Rating

In Continental Tire of the Americas v. IWCC, 2015 IL App. (5th) 140445WC, the Appellate Court considered the issue of permanent partial disability per Section 8.1b(b).

Petitioner sustained a left wrist injury in a compensable work accident. Prior to arbitration, Respondent secured an AMA impairment rating of 0% from Dr. David Brown, pursuant to Section 8.1b(a). Petitioner did not obtain or admit an AMA impairment rating report.

The arbitrator awarded Petitioner 5% loss of use of the left hand. Respondent appealed, and the Commission affirmed. Respondent appealed to the Circuit Court, which also affirmed.

On appeal, Respondent argued that Petitioner's PPD request should have been denied because he did not present a physician's report supporting a PPD finding. Respondent also argued that the Commission failed to give proper weight to Dr. Brown's impairment report, Petitioner's extremely limited treatment and his return to full duty at his prior earning capacity.

The Appellate Court affirmed the Commission's decision. The Commission reasoned that Section 8.1b(a) does not require each party to submit an AMA impairment rating report and such reports are to be considered along with the other four factors under 8.1b(b).

Practice Tip:

The decision in *Continental Tire* reassures us of the interpretation and impact (or lack thereof) of AMA impairment ratings and PPD awards. In evaluating PPD, it is important to consider all five factors (age, occupation, future earning capacity, corroboration of medical records and AMA impairment rating.)
