Top 5 Defense Tools You Shouldn't Overlook

Everyone knows that IME's, UR, Surveillance are effective defense tools. Here are some tools that are often overlooked that can really save you money:

1/Medical Provider Canvas:

It is imperative to know as much about a claimant's prior medical history as possible. If you are limiting your search to only those providers that the claimant has identified, you are only accomplishing half of your goal. A medical provider canvas is a very effective and inexpensive way to gather this information.

2/ ISO Report:

Again, information is power. Knowing your claimant's claim history is imperative to your defense

3/Personnel File:

There is frequently invaluable negative information in a claimant's personnel file. For example, disciplinary action close to an alleged accident date raises significant red flags that can help you dispute a questionable claim.

4/ Records Review:

Have you ever read an IME report hoping that it would give you what you wanted, only to be burned? An effective way to avoid that is to get a preview of the opinion through a records review only. If the doctor ends up giving you an opinion that you don't like, you do not need to disclose it.

5/ Motion to Dismiss:

While the Illinois Workers' Compensation Act does not explicitly allow for motions to dismiss, such motions are a tool that we use frequently to move cases forward. When a claimant is not compliant with medical treatment, misses IME's or skips out of vocational rehabilitation appointments, file a motion to dismiss, asserting that Petitioner is not fulfilling his or her duties in moving the case forward.

Rich Lenkov: You mentioned Eddie Johnson, head of the police department here in Chicago. He was heavily criticized on social media for not coming out right away and stating that this was a hate crime. If this happened on your watch and you had a video where the attacker shouted "f*** white people," and the victim was a special needs teen, would you have come out and said this was a hate crime? Or do you think Eddie Johnson handled it correctly?



David Clarke: I want to be a little careful because I don't have all the information that he had. **That being said, it's a no-brainer. Of course it was a hate crime.** But that's not a satisfying answer. It doesn't solve the real issue that needs to be dealt with here: how do we reduce the size of the black dysfunctional subculture that exists in many

neighborhoods in the city of Chicago so that we don't see a recurring incident of this. The number of murder victims has been going up year after year so that tells you that they're not dealing with this.

Forget about root causes. I'm talking about risk factors that lead to kids growing up without fathers. We know that when a young boy grows up without a father, to help him socially develop, he ends up turning into an unmanageable misfit that the police in the criminal justice system have to deal with. Those are the issues I would've liked Superintendent Johnson to talk about, some of these urban pathologies. Put this on the political class, "hey, you've tied the hands of my officers on the street because of this Laguan McDonald case."

But, of course, he works for Rahm Emmanuel and he can't throw the mayor under the bus or he'll be fired. At the same time, this should be important enough for Superintendent Johnson to speak up.

Commission Reduces PPD Award Due To AMA Rating

In *Flexible Staffing v. IWCC*, 2016 IL App (1st) 151300WC, the Appellate Court affirmed the Commission's modification of the arbitrator's permanency award. The award was reduced from 30% loss of the right arm to 25%, based primarily on consideration of an AMA impairment rating.

Petitioner, a welder, injured his right bicep when he attempted to catch a metal railroad rail, weighing 400 pounds, resulting in a distal bicep tendon rupture. Petitioner underwent surgery with Dr. Arabindi, after which Petitioner completed physical therapy. Following therapy, Dr. Aribindi discharged Petitioner with instructions to return to full duty work.

Upon Petitioner's discharge, Respondent scheduled an IME and AMA Impairment Rating with Dr. Mark Levin. Dr. Levin assessed a 6% upper extremity impairment.

At trial, the arbitrator awarded 30% of the right arm, applying the factors set forth in Section 8.1b of the Act.

On Respondent's appeal, the Commission reduced the award to 25% of the right arm. The Commission did not elaborate as to the basis for the reduction. Petitioner appealed.

The Circuit Court remanded to the Commission with an instruction to articulate the facts and reasoning for the reduction. On remand, the Commission outlined its weighing of all 5 factors pursuant to Section 8.1b, noting that the impairment rating was not given any more weight than any other factor and maintained its 25% loss of the right arm award.

Petitioner again appealed to the Circuit Court, which affirmed the Commission decision. Petitioner then appealed to the Appellate Court, which also affirmed the Commission decision.

Practice Tip:

When permanency is at issue at trial, always obtain an AMA impairment rating from a qualified physician.

These Boots Are Made For... Falling

In *Jackson v. Lincoln's Challenge*, 24 ILWCLB 18, the Commission denied benefits after Petitioner's combat-style boots were caught on a work step.

Petitioner worked at a military school, training "at-risk" youth. He was required to wear a military uniform, which included combat boots.

On the accident date, Petitioner was moving cadets downstairs. As Petitioner walked down the stairs, his boot became caught on a stair and he injured his left knee.

At arbitration, the evidence proved that the stairs had no defects and there was nothing wrong with Petitioner's boots. Petitioner also testified that he used those stairs 20-25 times a day but was not in a hurry at the time of the accident.

The arbitrator and Commission denied benefits, stating that the accident did not arise out of Petitioner's employment. Petitioner unsuccessfully tried to rely on *Young v. IWCC*, 13 N.E.3d 1252 (III. App. 4th Dist. 2014). In *Young*, Petitioner was awarded benefits for injuring his arm while reaching into a deep container to pick out parts. In this case, however, the Commission determined that Petitioner was engaging in an act of daily living by walking down stairs.

Practice Tip:

Interestingly, Petitioner did not rely on the quantitative risk of using the stairs 20-25 times per day. This is an excellent case to cite in support of an accident defense for injuries involving stairs where there are no defects.
